

Promotion Terms and Conditions
Emit EzSolar Promotion for Single Phase with Small System Size (“Promotion”)

These Terms and Conditions govern the Promotional campaign organized by Time Energy Sdn. Bhd. (“Time” or “Company”). By participating in this Promotion, you (“Participant”) are deemed to have read, understood, agreed to be legally bound by these Terms and Conditions stated herein and Time Energy’s Privacy Policy available at <https://www.emitsolar.com/privacy-policy/> (“Terms”). This Promotion, of which the Terms are set out as below is available only to customers who qualify for the Promotion. These Terms shall be read together with any general terms and conditions of Time available at <https://www.emitsolar.com> (“Solar General T&C”), or any relevant documents required by Time that will be made available to the Participant. Time reserves the right to modify, suspend, or terminate the Promotion at any time without any prior notice. By continuing to access or use the service or participating in the Promotion, you are deemed to have accepted the changes and updates to these Terms.

Promotional Benefit or Promotion Type	Eligible Customers who sign up for TIME’s Emit Solar Plan with EzSolar will receive the following: (a) For Eligible Customers signing up for an EzSolar 5-year plan, a waiver of six (6) months’ fees shall be granted and applied to the fees payable for the 4th to 9th billing months; and (b) for Eligible Customers signing up for an EzSolar 10-year plan, a waiver of three (3) months’ fees shall be granted and applied to the fees payable for the 4th, 5th and 6th billing months. This Promotion is effective from 29 January 2026, while stocks last, and subject to availability.
Promotion Conditions	New customers who meet the conditions below (“Eligible Customers”) are eligible for this Promotion. To be eligible for this promotion, customers shall: a. be new Time customers (including customers who registered via Time’s website (https://www.emitsolar.com/) but whose technical proposal is only issued or accepted during the Promotion Period); b. be a resident or domiciled in an area where Time provides its products and services; c. sign up for single-phase supply with applicable system sizes between 4.59 kWp to 6.63 kWp; and d. select EzSolar payment option for the technical proposal and sales order. Customers must also fulfil all of the following conditions to be eligible for the Promotion: e. extend their full cooperation for Time to conduct a site survey, if applicable; f. accept and sign the technical proposal within two (2) weeks from the proposal date; g. accept and sign the sales order within two (2) weeks from the

	sales order date; h. complete payment as specified in the technical proposal or sales order (including payment of the three (3) months' deposit) within 3 days of receiving the invoice (note that the deposit specified in the service order or proposal is refundable if the installation is cancelled with at least seven (7) working days' written notice to Time); i. submit all complete documentation as may be required by Time; and j. fulfil all other conditions as stated in these Terms and as may be required by Time. Notes: k. Customers who sign up within the Promotion Period remain entitled to the Promotion even if installation occurs after the Promotion Period, provided that the conditions set out in these Terms are fulfilled. l. Failure to accept the technical proposal and sales order within the stated timeline will result in forfeiture of promotional entitlement. m. All approvals from Time will be evaluated on a case-by-case basis, subject to Time's discretion. n. Where a customer fails to fulfil any of the Promotion Conditions set out above (where applicable, within the prescribed timelines), Time reserves the right, at its sole discretion, to determine the customer's eligibility for the Promotion and/or to withdraw, withhold or vary any Promotional entitlement.
Promotion Period	The Promotion Period shall commence on 29 January 2026 and continue while stocks last and subject to availability. Any subsequent redemptions, registrations, or applications made after the end of the Promotion Period shall not be entertained or be entitled to the promotional benefits.
Method of Redemption	a. A three (3) month deposit will be required upon confirmation of sales order for auto-billing and system setup purposes. b. The deposit collected will be utilized to offset the monthly charges for the 4th, 5th and 6th month, resulting in a waiver of the said monthly charges. This shall apply for the Promotions for both the EzSolar 5-year plan and EzSolar 10-year plan. c. The Eligible Customer's contracted monthly subscription amount remains unchanged throughout the contract term as stated in the sales order. d. The Promotion does not reduce or alter the system price or monthly rate and only provides a waiver of payment of monthly charges for the specified months.
Miscellaneous	The applicability of this Promotion in relation to the Participant's use of the solar photovoltaic system is subject to and is to be read together with the Solar General T&C. All terms and definitions outlined in the Solar General T&C shall be incorporated by reference and shall have the same meaning and interpretation in

	this Promotion unless explicitly stated otherwise. In the event of any conflict, inconsistency or ambiguity between the provisions of this Promotion and the Solar General T&C, the terms of the Solar General T&C shall prevail.

General Terms and Conditions

1. This Promotion is only applicable during the Promotion Period. Time reserves the right to cease and/or cancel the Promotion at any time before the expiry of the Promotion Period without any prior notice.
2. This Promotion is only available to Participants who are Eligible Customers subject to Eligible Customers' fulfillment of the Promotion Conditions. Any Participants that do not meet the Promotion Conditions is not an Eligible Customer and therefore is not entitled to the Promotion.
3. This Promotion is not transferable to any third-party, is non-negotiable and non-exchangable for cash in part or in full.
4. Time reserves the right to substitute, change, amend, or modify this Promotion and its value and/or benefits with other rewards of similar value at any time without prior notice. This Promotion is provided by Time on an "as is" basis.
5. There is nothing in these Terms that shall imply that an Eligible Customer is to receive any other benefit beyond what is laid out in the Promotion Details, nor is Time obliged to provide the equivalent value or Promotion Type if Time changes, amends or modifies the Promotion.

14. Any advice or information (whether oral or written) obtained from Time does not create any warranty, and you should not rely on such statements as a guarantee. Time, its officers, employees, representatives, and agents (including any third-party service providers engaged for the Promotion), shall not be responsible for or accept any liability of any kind arising from the Promotion, whether directly or indirectly suffered by you or any third parties, except in cases of Time’s gross negligence or willful misconduct specifically related to the Promotion.

18. You hereby warrant that in your participation of this Promotion, you consent to the collection, processing, and use of your personal data by Time in accordance with Time’s Privacy Policy. In addition, you agree to the use of your personal data by Time for:
 - (a) purposes related to the Promotion; and
 - (b) marketing and promotional activities related to the Promotion conducted by Time, which may include various forms of advertising and publicity through media such as newspapers, television, radio, and online platforms. This may involve the use of details from your entries, interview materials, responses, and related photographs.
